The goal of this educational approach is for individuals to achieve social independence and dignity, and benefit from and contribute to society. A Better Chance School uses a multi-disciplinary, holistic approach to education of our students. Our students are educated through the development of their physical. emotional, and intellectual selves. The final goal our educational approach is to have each student realize and reach his or her full potential. A Better Chance School offers a variety of innovative, educational classes covering topics such as behavioral therapy, independent living, social and recreational skills, and vocational training. Ongoing specialty classes include Speech and Language, Art, Music, Physical Education, and Culinary Arts. Every student receives an individualized functional academic program. Each student's Individualized Education Plan (IEP) is taught in an integrated manner to ensure consistency and systematic learning. Each goal is broken down into smaller steps, allowing the student to be introduced to new concepts only after they master prerequisites. Students are regularly assessed, through alternative assessments, portfolios, written documentation, the IEP document, and quarterly progress notes. Students are mainstreamed into less restrictive programs as soon as possible. Our individualized transition services help students to make a successful transition in their next program. Graduating students of A Better Chance School will transition from school to adult life with many work skills and community experiences that will ensure future success.
